- Acceptance to my course is subject to successful completion of a selection and/or interview process and I agree that IH Sydney in its absolute discretion, may accept or reject my application to undertake the course.
- Once a place has been offered, it can only be secured when a deposit or full fee has been paid as stated in the invoice. A late payment fee of \$100.00 per week applies (capped at \$200.00). I agree that if I do not pay the balance of fees 14 days prior to course commencement that my position on the course can be offered to another candidate.
- I acknowledge that the school is closed on public holidays, and that these dates are specified on the IH Sydney website:

- A transfer request from/to IH Sydney within 6 months of the principal course is only accepted where a release letter is received/issued by IH Sydney and in accordance with Standard 7 of National Code.
- I understand that all enrolments in ELICOS courses of 24 or fewer weeks constitutes as one course. Once I have commenced my course, I am not entitled to a refund for any unused weeks or tuition.
- IH Sydney reserves the right to increase fees at any time and to cancel a course if there is an insufficient number of candidates. In the event of a course not being delivered, I am still covered by the Tuition Protection Service (TPS), an initiative of the Australian Government to assist international students whose education providers are unable to fully deliver their course of study. The TPS ensures that international students are able to either:
 - complete their studies in another course or with another education provider or
 - receive a refund of their unspent tuition fees.
- I need to disclose, during my interview, any medical problem that may affect my ability to participate in, and/or complete the course I am applying for in accordance with the course requirements
- I, as an ELICOS student, must attend 100% of classes or I will be breaching Student Visa conditions. IH Sydney must report ELICOS students with less than 80% attendance to the Australian Government Department of Immigration and Border Protection (DIBP) and this could result in a Visa cancellation.
- The following may affect my grade and may be grounds for dismissal from the course:
 - failure on my part to co-operate reasonably with other trainees, students, IH Sydney personnel and third parties such as, but not limited to, work experience providers
 - non compliance on my part with the IH Sydney code of conduct. A copy of the code can be obtained from IH Sydney.
 - Failure on my part to complete any written assignments on time and to a satisfactory standard will affect my grade. I accept as final all decisions made by IH Sydney in regard to certification, grading and dismissal from the course. A fee of \$200 per unit applies to re-sit assessments.
- I accept financial responsibility for any books and materials borrowed by me
- Trainees/students on IH Sydney courses will have different trainers/ teachers during their courses and class sizes and timetables may vary.
- That this written agreement, and the right to make complaints and seek appeals of decisions and action under various processes, does not affect the rights of the student to take action under the Australian Consumer Law, if applicable.
- I understand that if I am on a Student Visa it is my responsibility to advise IH Sydney of my current residential address on arrival and if I change my address, I must notify the centre immediately. I am aware that failure to notify the centre may result in automatic cancellation of my visa without my knowledge.
- I am responsible for keeping a copy of this agreement, as well as any receipts of payment.
- By studying at ihBC I agree to respect the student code of conduct provided on the learning portal.
- Administration Fees:
 - Change of VET Course: \$100.00.
 - Cancellation Fee: \$250.00 Unless we receive 28 days notice before original term start date.
 - Change of campus: Free, when no change to COE is needed.

- Deferral of VET Term: \$100.00 Unless student enrolls into another IH course.
- Change of COE: \$50.00 per request, regardless of the number of COEs. No charge if the change is due to delay in visa issuance.

SPECIAL CIRCUMSTANCES, COMPELLING AND COMPASSIONATE REASONS TO CANCEL OR DEFER FROM A COURSE

Special circumstances, compelling and compassionate reasons are defined by: death of close family such as parents, siblings, children and grandparents, serious illness and life threatening conditions, involvement into a traumatic event such as experiencing or witnessing a crime.

Application with special circumstances, compelling and compassionate reasons must be supported by documents and the application form.

RECOGNITION OF PRIOR LEARNING (RPL)

All students can apply for Recognition of Prior Learning for any of the units included into their course. Students can have their prior learning recognised by IH Sydney if they submit an application prior the course starting date. Students can request an RPL kit to prepare for their application. Each application will be assessed within two weeks of being received by the college and the approval will depend on the assessment. If a student has some Recognition of Prior Learning then the duration of the course will be reduced accordingly. If a student on a Student Visa is granted RPL for one or more units prior to commencing their qualification, the school will calculate the proportion of the course that the RPL involves and the course length will be shortened to the length of full-time study remaining in the course. If RPL is granted after arrival in Australia and after visa issue, the school has the responsibility to inform Department of Home Affairs of the shortened length of the course. As a result, their visa will be adjusted accordingly.

Payment of \$250 per unit is required, to be paid by the student at the time of applying for RPL.

CREDIT TRANSFER

Course credit and recognition of prior learning is part of a system to allow students to provide the appropriate evidence to achieve course credit and to acknowledge and accommodate the recognition of other RTO qualifications and statements of attainment.

Students need to apply for course credit in writing with supporting evidence as required before their course starts. If the course credit is granted before the student visa grant, indicate the actual net course duration (as reduced by course credit) in the confirmation of enrolment issued for that student for that course, or if the course credit is granted after the student visa grant, report the change of course duration via PRISMS under section 19 of the ESOS Act.

I ACCEPT THE FOLLOWING REFUND POLICY

- More than 28 working days written notice before the original course start date: Full refund of tuition fees less any enrolment fees, additional fees, course deposit and accommodation booking fees. A \$300 Admin Fee applies to all refunds.
- 28 working days or less but greater than 14 working days written notice before the original course start date: 80% of tuition fees less any enrolment fees, additional fees, course deposit and accommodation booking fees. A \$300 Admin Fee applies to all refunds.
- 14 working days or less written notice before the original course start date: 0% refund. There is no refund of tuition or any fees for cancellation fewer than 14 working days before the original course start date.

NOTES TO REFUND POLICY

- Payments received directly from agents are refunded to the agent. Payments received directly from students are refunded directly to the student.
- It may be possible, up to two weeks before a course starts, to transfer to a later course date
- CELTA deposits are non refundable. Deferrals may be considered under special circumstances, a fee of \$250 applies.
- No refund will be issued if I do not commence a course for which I have paid or if I withdraw after I have commenced the course
- If my visa application is denied, a full refund of all unused Course fees and related fees, less the enrolment fee, will be made provided that IH Sydney receives a copy of the Australian Embassy rejection letter prior to course commencement and within 24 hours of the default date. Refunds will be paid after a minimum of 8 weeks of receipt of the written claim, and possibly longer, at the discretion of IH Sydney Training Services Pty Ltd. In the case of a visa refusal based on fraudulent documents, including false statements in the GTE form, no refund will be issued.
- IH Sydney will issue a full refund in the event of a course being cancelled or not completed by IH Sydney due to insufficient numbers or any other reason. In this event, the full refund will be paid within 2 weeks after the provider default date.
- If I request a refund, I will do so in writing addressed to the Principal of the centre, stating the reason for my request and including all other necessary information that support this request. In the event that a refund is granted by IH Sydney, it shall be paid after a minimum of 4 weeks of receipt of the written claim, at the discretion of IH Sydney Training Services Pty Ltd. An Admin Fee of \$300 applies to all refunds.
